SUMMARY

Before the City Council is a purchase and sale agreement (PSA) for a portion of Clarke Beach Park at 7700 East Mercer Way. See Exhibit 1. This portion of the Park was declared as surplus to the City's public parks and recreation needs by Mercer Island City Council on July 7, 2014. See Exhibit 2.

History of the Property

Clarke Beach was originally acquired in 1969 and 1970 by the City of Mercer Island with Washington State marine recreation funds. Under the funding agreement, conversion of the property or any portion thereof requires approval from the Washington State Recreation and Conservation Office ("RCO").

In 2006, the property adjacent to Clark Beach at 7900 East Mercer Way was redeveloped. Rockeries, drainage, pavement and landscaping were installed, without City authorization, on the Clarke Beach property. The new home changed ownership twice in the following three years. The current owners had no prior knowledge of the encroachments when they bought the property and have been working with the City to resolve the encroachment issue.

The portion of Clarke Beach declared as surplus ("the Property") measures only 2,584 square feet. The addition of rockeries and hardscape has made this area unfit for restoration. Removing them would destabilize the slope and therefore would become prohibitively expensive. The encroachments also represent a current liability to the City.

The owners of the adjacent property have agreed to purchase the Property.

Public Notice

The property surplus proposal was properly noticed in the Mercer Island Reporter on April 16, 2014. In addition, a letter was sent to all residents within 300 feet of the park on April 10. These actions meet or exceed the RCO requirements for public involvement. No objections to the property surplus proposal were received.

Procedure

In 2012, Parks and Recreation Director Bruce Fletcher sent a letter to RCO requesting a conversion of a portion of Clarke Beach by way of sale to resolve the encroachments on Clarke Beach. The proposal includes conveying the Property to the adjacent property owner by adjusting the property boundaries through an official Lot Line Revision. The RCO has reviewed the conversion request and has informed the City that the proposal could meet the requirements if the City fulfills certain conditions including that the sale price meet or exceed the price set by an the Uniform Standards of Professional Appraisal Practice (USPAP). In the case of Clarke Beach and the nature of original funding sources for the acquisition, RCO required a "before and after" appraisal analysis. The initial appraisal considered what the subdivision potential would be both with and without the conversion property. The initial appraisal was then reviewed by an independent appraiser and the result of the review appraisal confirmed the value point that RCO is using.

At the June 3, 2013 Study Session, the City Council received a report on this situation. See Exhibit 3. Staff identified that next steps would be to proceed with a survey and appraisal of the Property.

On July 7, 2014, the City Council passed Resolution No. 1482, attached as Exhibit 4, declaring the Property surplus to the City's public parks and recreation needs. Staff has moved forward to prepare for sale of the Property. The survey and appraisal have been completed and submitted to RCO for approval.

Staff recommends that the Council direct the City Manager to sign the Purchase and Sale Agreement. The purchaser and the City will proceed with fulfilling the conditions of sale. The contract requires that this be completed within 180 days.

Conditions of Sale

The Purchase and Sale agreement sets several conditions for the sale of the Property, as follows:

- The Mercer Island City Council authorization of the Purchase and Sale agreement
- The ability of the purchaser to finance the sale
- The approval of the sale from the State Recreation and Conservation Office (RCO)
- The completion of a Lot Line Revision per City Code at the expense of the purchaser
- The completion of a drainage easement to convey surface water across the property.

Staff anticipates that the completion of the sale will occur in the first quarter of 2015.

SUMMARY

Before the City Council is a proposed resolution declaring a portion of Clarke Beach Park at 7700 East Mercer Way as surplus to the City's public parks and recreation needs. If the City Council declares the property to be surplus, it may then direct the City Manager how to dispose of the property.

Background

The City of Mercer Island owns approximately 9.05 acres of property known as Clarke Beach Park ("Clarke Beach") at the south end of Mercer Island. Clarke Beach was originally acquired in 1969 and 1970 by the City of Mercer Island with Washington State marine recreation funds. The funding agreement included conditions for when a portion of the land is "converted" to other purposes, including sale of the property. Conversion requires approval from the Washington State Recreation and Conservation Office ("RCO"), the state agency in charge of oversight for grant awarded projects and land acquisition.

In 2005 and 2006, a property next to the south boundary of Clarke Beach was redeveloped. The developer encroached onto Clarke Beach with a patio, steps, rockeries, drainage and landscaping (see Exhibit 2). The area of encroachment ("the Property") measures 2584 square feet. There are no records of what the Property contained prior to redevelopment, but the location on the south boundary of a forested open space, the steep slope topography and the observed condition of the trees suggest that this was a degraded forest edge habitat.

The current owner and the City were unaware of the encroachment at the time. An existing chain link fence gave the wrong impression of the location of the property boundary. The City became aware of the encroachment in 2009 and conducted a survey in 2010 (see Exhibit 2). The adjacent property owner was

notified at that time, and he continues to express a desire to work with the City and State to resolve the situation.

The addition of rockeries and hardscape has made this area unfit for restoration and only benefits the adjacent property. Removing them would destabilize the slope and therefore would become prohibitively expensive. Additionally, they represent a liability to the City.

In 2012, Parks and Recreation Director Bruce Fletcher sent a letter to RCO requesting a conversion of a portion of Clarke Beach by way of sale to resolve the situation. The proposal includes conveying the Property to the adjacent property owner by adjusting the property boundaries through an official Lot Line Revision. The RCO has reviewed the conversion request and has informed the City that the proposal could meet the requirements if the City fulfills certain conditions. According to a RCO representative, the sale will likely be considered a minor conversion, which could be handled by the Director of RCO, rather than by the RCO board. Given these considerations, this Property has become surplus to the City's parks and recreation needs.

On June 3, 2013, the City Council received a report (AB 4839) on this situation in study session. At that time, Councilmembers were informed that staff would proceed with survey and appraisal of the Property. No objections were raised and staff has moved forward to prepare for sale of the property. The survey and appraisal have been completed and submitted to RCO for approval.

Because this property was not originally acquired for public utility purposes, state law does not dictate a specific process to sell or dispose of the Property. The most important legal consideration is that the City receive fair market value for the Property, to avoid a gift of public property to a private party. The City must also meet RCO requirements, including public involvement in the surplus of the property. The property surplus proposal was noticed in the Mercer Island Reporter on April 16, 2014. In addition, a letter was sent to all residents within 300 feet of the park on April 10. These actions meet or exceed the RCO requirements for public involvement. No objections to the property surplus proposal were received.

To dispose of the Property, the City first declares the Property as surplus to the City's needs and then specifies how the property is to be sold.

Additional Considerations

RCO also has specific requirements for the sale of conversion property which must be followed, including that the property sale price is set by a review of its appraised value. RCO will require the City to acquire property of equivalent or greater value and recreational function as the Property. City staff have been working to identify replacement property candidates. The property acquisition will be considered in a separate agenda bill at a future City Council meeting.

SUMMARY

BACKGROUND

Clarke Beach was purchased by the City with matching funding from a Washington State grant program in 1969 and 1970. As a condition of the grant, the land must be used for "marine recreational purposes." The funding agreement also included conditions for when a portion of the land is "converted" to other purposes, including sale of the property. Conversion requires approval from the Washington State Recreation and Conservation Office (RCO), the state agency in charge of oversight for grant awarded projects and land acquisition.

In 2005 and 2006, a property next to the south boundary of Clarke Beach was redeveloped. The developer encroached onto the City property with a patio, steps, rockeries, drainage and landscaping (see Exhibit 1). The area of encroachment ("the Clarke Beach Property") measures approximately 2500 square feet. The current owner and the City were unaware of the encroachment at the time. The City became aware of the encroachment in 2009 and conducted a survey in 2010 (see Exhibit 2). The property owner was notified at that time, and he continues to express a desire to work with the City and State to resolve the situation.

In 2012, Parks and Recreation Director Bruce Fletcher sent a letter to RCO requesting a conversion of a portion of the Clarke Beach Property by way of sale to resolve the situation. The proposal includes conveying the portion of the property with the encroachments to the adjacent property owner by adjusting the property boundaries through an official Lot Line Revision. The RCO has reviewed the conversion request and has informed the City that the proposal could meet the requirements if the City fulfills certain conditions. According to a RCO representative, the sale will likely be considered a minor conversion, which could be handled by the Director of RCO, rather than by the RCO board. The representative also said that other jurisdictions are currently dealing with similar situations, which provides precedent for how to

administer the conversion. The most significant condition of the sale will require the City to acquire property of equivalent or greater value and recreational function as the sold portion of the Clarke Beach property.

In his letter to RCO, Director Fletcher proposed that the property next to the SE 47th Open Space be acquired to satisfy the RCO's replacement requirements for conversion (see Exhibit 3 and AB 4841). This property is the current location of a private trail and would enable a new public trail corridor to follow the natural contours of the land, rather than the up and down steep route constrained by the City right of way. The owner has expressed interest in selling to the City. The RCO representative reviewed the proposed replacement property and found it to be satisfactory as a replacement for the Clarke Beach conversion.

PROPOSAL

Staff propose that the Mercer Island City Council sell approximately 2500 square feet of Clarke Beach Park to the homeowner at 7900 East Mercer Way and use the proceeds of the sale to purchase a replacement property of the same value to add to the City's trail system.

SALE PRICE, COSTS AND FUNDING

The sale price of the Clarke Beach property will be determined by appraisal. RCO has specific standards of appraisal for a conversion. RCO also requires that the replacement property be appraised using the same method as the conversion property. Staff is awaiting Council's direction on this matter before proceeding with this step. However, staff has looked at square foot costs for undeveloped lots along East and West Mercer Way on the south end of the Island. Based on this crude method, the estimated value of the portion of Clarke Beach property could range from \$20,000 to \$50,000.

These property transactions involve several expenses, including title reports, appraisals, surveys, permit fees for the Lot Line Revision and recording costs, estimated at \$8,000. Transaction costs of the Clarke Beach sale would be paid by the buyer. Transaction costs of the replacement property purchase would be paid by the City using King County Proposition 2 Levy funding which is already budgeted at \$80,000 for trail acquisition and development.

PROCESS

If the City Council supports this proposal, the next step would be adopting a resolution declaring the property surplus and authorizing the sale. State law and RCO require that this process include a public hearing. RCO also requires a 30-day comment period for a conversion process. RCO does not require that the conversion sale and replacement sale occur simultaneously. However, the replacement property should be identified and appraised within six months of appraising Clarke Beach in order for the appraisals to be comparable. The Lot Line Revision will be subject to a City permit process.

ALTERNATIVES TO SELLING THE CLARKE BEACH ENCROACHMENT

Allowing the encroachment to remain is not an option because of provisions in the original acquisition agreement between the City and the State. An alternative to selling the property at Clarke Beach is to keep it as City open space and restore it to conform with the intended purpose of the acquisition. The area to the north of the encroachment is forested hillside and it has a moderate amount of invasive, non-native plants. The encroachment itself contains mostly non-native landscape plants and presumably, the area could be restored to a native forest condition. However, there are significant retaining walls that the City would be responsible for maintaining. The primary function of these walls is to hold the slope to support and protect the house at 7900 East Mercer Way. Additionally, a concrete patio would be cut and removed, and an area of lawn would be reclaimed as open space. There would be considerable expense in this restoration. The funding for these corrections has not been discussed. The house would remain a non-conforming structure because of inadequate setback from the lot line.

ALTERNATIVE ACQUISITION FORMS

The City Attorney and Parks and Recreation staff explored several forms of acquisition for the trail corridor at the SE 47th Open Space, including right-of-way, easement, and fee. A trail easement on an existing property is the preferred option. The easement allows the City to acquire the necessary rights with a reasonable amount of process. Fee acquisition of the parcel would be very difficult and costly. A short plat would not be allowed because the subdivision process would create a non-developable lot which is prohibited in state law. A plat revision creating a tract would involve an extensive public process that is out of scale to the project. Acquiring the trail as right-of-way does not provide any real advantages over a simpler easement, and includes rights and responsibilities that the City does not need and would entail additional costs. A trail easement does not burden the underlying property rights as significantly and more total land area can be acquired to improve the location trail route.

ALTERNATIVE REPLACEMENT PROPERTIES

As discussed above, Parks and Recreation staff asked RCO staff to evaluate the east portion of 4680 91st Avenue SE next to SE 47th Open Space as a replacement property. The area is a moderately steep forested slope. A trail and conservation easement on this property would improve the alignment of the proposed SE 47th trail by enabling a gradual ascent of the slope, rather than an up and down route dictated by the constraint of the existing right-of-way. The property owners have expressed interest in this transaction.

Parks and Recreation staff also evaluated an alternative property as a potential candidate for a trail and fulfilling RCO's requirements. The Timberland trail is an informal trail in the 6100 block of East Mercer Way. The existing trail is located on an undeveloped 19,970 square foot lot and runs partially on a nearby utility easement. The property is owned by a family trust. A 20' wide trail easement would enable future construction of a trail and staircase to relocate the trail entirely on the north side of the property. This configuration would allow the trail to remain with the least impact on the property's development potential. It is not certain that this easement would appraise at a value similar to that of the Clarke Beach conversion property. A representative of the family has been receptive to initial contact, but staff has not received an indication of willingness to sell.

Advantages of the SE 47th Trail easement:

- Makes the ascent of a steep slope more gradual, making the trail easier to use.
- The size of the acquisition is flexible and can be matched to the value of the Clarke Beach acquisition.
- The owners have indicated they are willing sellers.
- A conservation easement would add open space to an existing open space. The current open space is a narrow corridor and does not conserve habitat well in its current configuration.
- This pedestrian connection is supported by the Pedestrian and Bicycle Facilities Plan.
- The easement decreases subsequent construction costs to build the trail.

Disadvantages of the SE 47th Trail easement:

- This acquisition is not required to make this neighborhood connection occur, it only improves it.
- It is only a viable RCO replacement property with the acquisition of the trail easement at 9333 SE 47th Street (see AB 4841).
- It is likely this property could be purchased using other funding. It is a reasonable candidate for King County Conservation Futures Funding, which would provide 50% of the cost. The Timberland Trail would not be as good a fit for that funding.

Advantages of the Timberland Trail easement:

- Preserves an existing neighborhood connection that might go away at some future date
- · Resolves a potential development conflict
- · Acquires a new public trail easement.
- Construction costs would be substantially less than for the SE 47th Trail.
- The transaction stands alone. It is not dependent on other acquisitions to be functional.

Disadvantages of the Timberland Trail easement:

- The trail easement is constrained in size and location.
- The trail easement may appraise for less than the Clarke Beach conversion. That makes it less suitable for a replacement property unless additional property can be acquired.
- The easement does not adjoin any open space so a conservation easement is not a useful public benefit.
- There would be additional costs to construct the required staircase.
- The owners have not indicated they are willing sellers'.

Some consideration should be given to the logistics around the Clarke Beach sale. The RCO gives a 6-month window for finding and appraising a replacement property. In addition, RCO requires that the replacement property is equal or greater in value to the conversion property. Both of these considerations advantage the SE 47th Trail as a replacement target.

RECOMMENDATION

Parks Natural Resources Coordinator

Discuss proposed sale and replacement proposals.

A RESOLUTION OF THE CITY OF MERCER ISLAND, WASHINGTON DECLARING A PORTION OF CLARKE BEACH PARK LOCATED AT 7700 EAST MERCER WAY TO BE SURPLUS PROPERTY

WHEREAS, the City of Mercer Island ("City") owns property known as Clarke Beach Park, located at 7700 East Mercer Way ("Clarke Beach Park"); and

WHEREAS, Clarke Beach Park was acquired by the City in 1969 and 1970 using Washington State recreation funds to serve as the location for a park; and

WHEREAS, since its acquisition, Clarke Beach Park has been managed by the City's Parks and Recreation Department; and

WHEREAS, a 2,584 square foot portion of Clarke Beach Park ("the Property") was encroached upon during redevelopment of the home at 7900 East Mercer Way, including retaining walls that protect the home at 7900 East Mercer Way, and such encroachments have irrevocably displaced the park and recreational functions of this Property; and

WHEREAS, the Washington State Recreation and Conservation Office ("RCO") requires that any property purchased with state recreation funds that is no longer used for such purposes be "converted" to other purposes according to RCO policies and procedures; and

WHEREAS, pursuant to RCW 35.94.040, the City is authorized to determine by resolution of its legislative authority that any lands, property or equipment originally acquired for public purposes are surplus to the City's needs, and are not required for providing continued public service; and

WHEREAS, on June 13, 2013, the Mercer Island City Council considered this situation at Clarke Beach Park in study session, and considered various options for the property; and

WHEREAS, the City Council desires to declare the Property as a portion of Clarke Beach Park surplus to the needs of the City Parks and Recreation Department.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF MERCER ISLAND, WASHINGTON, AS FOLLOWS:

Section 1. Declaration of Surplus. The Property as a portion of Clarke Beach Park located at 7700 East Mercer Way is hereby declared no longer needed for providing public recreation, and is therefore surplus.

Section 2. Effective Date. This Resolution shall take effect and be in force immediately.

SUMMARY

BACKGROUND

Without additional revenue or significant cuts to the 2015-2020 Transportation Improvement Plan (TIP), staff projects a negative balance in the Street Fund of \$1.7 million in 2020. Based upon this projection, the Mercer Island City Council directed staff to "consider a transportation benefit district in the TIP for planning purposes (starting in 2015)".

On August 4, the Council held a study session to learn about the statutory-driven process of creating a Transportation Benefit District (TBD) to provide needed funding for the City's six-year TIP. The TIP is updated annually. Council learned how to create a TBD, how to raise funds and for what purpose the funds can be used. Following proper statutory notice, the Council held a public hearing on October 6 on the establishment of the TBD. Council also conducted the first reading of the ordinance creating the TBD.

Following Council direction, staff made several revisions to the proposed ordinance.

ESTABLISHMENT OF TBD

To create a TBD, the City must follow a specific statutory-driven process set forth in chapter 36.73 RCW. This statute prescribes the formation of a TBD, its allowed purposes, its governance, and its authority. The process to establish a TBD includes conducting a hearing and adopting an ordinance.

The ordinance establishes the boundaries of the TBD, specifies the functions of the district and the transportation improvements to be funded. Establishing a TBD is not subject to initiative and referendum.

PURPOSE OF TBD

State law allows a city to establish a TBD for the purpose of acquiring, constructing, improving, providing and funding "transportation improvements" within the district. The phrase "transportation improvement" is explicitly defined within the statute and means a "project" contained in the transportation plan of the state, regional planning organization, city or county. Additionally, transportation improvements must be necessitated by existing or reasonably foreseeable congestion levels and of statewide or regional significance.

Accordingly, the TBD must be used to fund transportation improvements within Mercer Island, that are tied to a state, regional or local transportation plan and are an investment in a principal arterial of regional significance or high capacity transportation, public transportation or other transportation projects of regional or statewide significance. The transportation improvements would be owned by the City and maintained by the City.

THE ORDINANCE

The proposed ordinance to establish the TBD is attached as Exhibit 1. It has been drafted to define the TBD's purpose as funding transportation improvements consistent with state, regional and local transportation plans. Doing so not only meets the statutory requirements, but also provides flexibility to best meet the City's transportation needs.

The ordinance authorizes the TBD to impose a \$20 vehicle fee. The City estimates this would raise approximately \$350,000 per year. Once the TBD is established and enacts an ordinance imposing the fee, the Department of Licensing can begin collecting this fee six months later.

Following Council direction after the first reading of the ordinance, staff updated the proposed ordinance to correct scrivener's errors and to expressly state that the TBD shall not issue general obligation bonds or revenue bonds.

NEXT STEPS

If Council adopts the ordinance and establishes the TBD, the TBD could hold its first meeting on Monday, October 27. The City Council acts *ex officio* and independently as the governing body of the TBD. The treasurer of the City (Finance Director) acts *ex officio* as the treasurer of the TBD.

One of the first acts needing to be performed by the TBD Board is to adopt a charter and bylaws, which will lay a foundation for how the TBD is to function. The bylaws contain the rules that govern the TBD. The charter outlines operating procedures including the following:

- Purpose of the TBD
- Powers and indemnification
- Roles and responsibilities of its officers
- The time and place for regular meetings

The TBD Board may then elect TBD officers, as specified in the bylaws.

The TBD Board must adopt a material change policy, which will lay a foundation for how the TBD is to address major plan changes that affect project delivery or the ability to finance the plan.

The TBD Board will need to vote on an ordinance to authorize a vehicle license fee (and/or a fee on commercial building construction or land development) and fix the time when the fee shall be effective.

The TBD Board also will need to adopt three interlocal agreements between the TBD and:

- the City of Mercer Island for staff support services;
- the Washington State Department of Licensing for the collection of vehicle license fees; and
- the Washington Cities Insurance Authority for errors/omissions and liability insurance.

NEXT STEPS

Staff recommends adopting Ordinance No. 14C-11 and setting the first TBD meeting on October 27, 2014.

CITY OF MERCER ISLAND ORDINANCE NO. 14C-11

AN ORDINANCE OF THE CITY OF MERCER ISLAND, WASHINGTON ENACTING A NEW CHAPTER 3.26 OF THE MERCER ISLAND CITY CODE, ENTITLED "MERCER ISLAND TRANSPORTATION BENEFIT DISTRICT" ESTABLISHING A TRANSPORTATION BENEFIT DISTRICT.

WHEREAS, the City Council of the City of Mercer Island has the responsibility under the Constitution of the State of Washington for the improvement, maintenance, protection and operation of public streets and ways within the corporation limits of the City pursuant to RCW 35A.11.020 and chapter 35A.47 RCW; and

WHEREAS, the improvement, maintenance, protection and operation of public streets and ways requires preserving existing transportation improvements to avoid both catastrophic failure that would require significant additional funds for reconstruction and to avoid their gradual deterioration that would lead to reduced safety margins and increased congestion; and

WHEREAS, the Washington Transportation Commission is mandated pursuant to RCW 47.01.071(4) to adopt the Washington Transportation Plan ("WTP 2035") which is a comprehensive and balanced statewide transportation plan that establishes a 20-year vision for the development of the statewide transportation system, from state highways and ferries to sidewalks and bike paths, county roads, city streets, public transit, air and rail; and

WHEREAS, WTP 2035 is based upon six transportation policy goals established by the Washington State Legislature and identifies maintaining, preserving and extending the life and utility of prior investments in transportation systems and services as a goal; and

WHEREAS, the Destination 2030 Metropolitan Transportation Plan for the Central Puget Sound approved by the Puget Sound Regional Council states that the first priority is to maintain, preserve, make safe, and optimize existing transportation infrastructure; and

WHEREAS, the Puget Sound Regional Council, a regional planning agency, has adopted its long-range strategy, VISION 2040, and its metropolitan transportation plan, Transportation 2040, which provide a framework for long-range transportation planning that integrates roads, transit, bicycling and walking, emphasizing clean and safe transportation; and

WHEREAS, the City's Capital Improvement Program, Transportation Improvement Plan, and the Transportation Element of the Comprehensive Plan, which are updated periodically, outline key strategies, objectives and investments for improving safety, mobility, modal connectivity, and access through providing effective transportation choices; and

WHEREAS, the City has limited transportation funding to pay for such necessary transportation preservation, maintenance and operation of streets and ways and current revenues will not sustain the current City transportation system; and

WHEREAS, on-going costs of preservation, maintenance and operation of streets and ways continue to increase, while dedicated revenues have decreased due in significant part to the loss of Motor Vehicle Excise Tax revenues formerly available to the City; and

WHEREAS, chapter 36.73 RCW provides for the establishment of Transportation Benefit Districts and for the levying of additional revenue sources for transportation improvements within the district that are consistent with existing state, regional or local transportation plans and necessitated by existing or reasonably foreseeable congestion levels; and

WHEREAS, RCW 35.21.225 authorizes the City Council to establish a Transportation Benefit District subject to the provisions of chapter 36.73 RCW; and

WHEREAS, the City Council finds that establishing a stable local funding mechanism for funding a portion of transportation improvements is essential to the continued mobility and the economic health and quality of life on Mercer Island; and

WHEREAS, the City Council now desires to form a Transportation Benefit District to include the entire boundaries of the City of Mercer Island as such boundaries currently exist; and

WHEREAS, prior to establishing a Transportation Benefit District, the City Council shall conduct a public hearing. The public hearing notice shall describe the functions and purposes of the proposed Transportation Benefit District, and proposed establishment of a Transportation Benefit District in accordance with RCW 36.73.050; and

WHEREAS, the City Council finds it to be in the best interests of the City to establish a citywide Transportation Benefit District for the preservation and maintenance of the City's transportation infrastructure consistent with chapter 36.73 RCW, to protect the City's long-term investments in that infrastructure, to reduce the risk of transportation facility failures and improve safety, to continue optimal performance of the infrastructure over time, and to avoid more expensive infrastructure replacements in the future; and

WHEREAS the City Council shall establish a governing body for the Transportation Benefit District comprised of the City Council acting in an ex officio and independent capacity.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MERCER ISLAND, WASHINGTON, DO ORDAINS AS FOLLOWS:

Section 1. <u>Create Mercer Island City Code Chapter 3.26, Transportation Benefit District.</u>

There is hereby added a new chapter of the Mercer Island City Code to read as follows:

Chapter 3.26 MERCER ISLAND TRANSPORTATION BENEFIT DISTRICT

Sections:

3.26.010 Purpose and findings

3.26.020 Transportation Benefit District established

3.26.030 Governing board

3.26.040 Purpose of the District

3.26.050 Authority of the District

3.26.060 Use of funds

3.26.070 Dissolution of the District

3.26.080 Liberal construction

3.26.010 Purpose and findings.

A. The purpose of this chapter is to establish a Transportation Benefit District pursuant to RCW 35.21.225 and RCW 36.73.

B. The City Council finds it is in the public interest to provide adequate levels of funding to make transportation improvements that are consistent with existing state, regional, and local transportation plans and necessitated by existing or reasonably foreseeable congestion levels as provided in Chapter 36.73 RCW. City Council further finds that it is in the public interest to invest in the operation, preservation and maintenance of principal arterials of regional significance, high capacity transportation and/or public transportation. City Council further finds that it is in the public interest to provide for transportation improvements that specifically focus on reducing the risk of transportation facility failure and improving safety, decreasing travel time, increasing daily and peak period trip capacity, improving modal connectivity, and preserving and maintaining optimal performance of transportation infrastructure over time so as to avoid more expensive infrastructure replacement in the future.

3.26.020 Transportation Benefit District established.

There is hereby established a Transportation Benefit District to be known as the Mercer Island Transportation Benefit District ("District") with geographical boundaries comprised of the corporate limits of the City of Mercer Island as they now exist or may hereafter be altered by future annexations.

3.26.030 Governing board.

- A. The governing board ("Board") of the District shall be the Mercer Island City Council acting in an ex officio and independent capacity, which shall have the authority to exercise the statutory powers set forth in chapter 36.73 RCW.
- B. The Treasurer of the District shall be the City's Finance Director.
- C. The Board shall develop a material change policy to address major plan changes that affect project delivery or the ability to finance the plan, pursuant to the requirements set forth in RCW 36.73.160(1).
- D. The Board shall issue an annual report pursuant to the requirements of RCW 36.73.160(2).

3.26.040 Purpose of the District.

The purpose of the District is to improve and protect the City's long-term investment in its transportation infrastructure, to reduce the risk of transportation facility failure, to improve safety, to avoid more expensive infrastructure replacements in the future, and to reduce congestion or stem the expected increase in congestion created by failing roads.

3.26.050 Authority of the District.

- A. The District shall have and may exercise any and all powers and functions provided by chapter 36.73 RCW to fulfill the purposes of the District, and this chapter of the Mercer Island Island Municipal Code shall be liberally construed to permit the accomplishments of the District's purposes.
- B. The District may authorize a vehicle tax fee up to the maximum fee provided for in RCW 36.73.065.
- C. The District may authorize a fee on building construction or land development as provided for in RCW 36.73.120.
- D. When authorized by the voters pursuant to the requirements of chapter 36.73 RCW, the District may assess other taxes, fees, charges and tolls or increases in these revenue sources for the improvement, preservation, maintenance and operation of city streets and ways.
- E. The District shall not issue general obligation bonds or revenue bonds in accordance with the provisions of RCW 36.73.070.
- F. The Board shall have and may exercise any powers provided by law to fulfill the purpose of the District.

3.26.060 Use of funds.

The funds generated by the District may be used for any purpose allowed by law including the operation of the District and to make transportation improvements that are consistent with existing state, regional and local transportation plans and necessitated by reasonably foreseeable congestion levels pursuant to chapter 36.73 RCW. The transportation improvements funded by the District shall be made in an effort to reduce the risk of transportation facility failure and improve safety, decrease travel time, increase daily and peak period trip capacity, improve modal connectivity, and preserve and maintain optimal performance of the infrastructure over time to avoid expensive infrastructure replacement in the future.

3.26.070 Dissolution of the District.

The District shall dissolve itself after all the indebtedness of the District has been retired or, if no debt has been incurred, when all of the District's anticipated responsibilities have been satisfied and the construction of the transportation improvement or series of improvements, has been completed and paid. Notice of dissolution shall be provided in accordance with RCW 36.73.170.

3.26.080 Liberal construction.

Much of the Council's review time will be spent in Section E (Recap by Fund) of the budget document, which addresses the following for each fund:

- Expenditure summary
- Fund balance
- Operating budget analysis

If interested, additional information on major revenue estimates is contained in Section D (Revenue Sources) of the budget document.

Staff will also review service enhancements (Section H) and significant budget policy issues/changes (Section I) related to each fund, which are identified on the next two pages.

The Executive Summary in Section B (Budget Message) highlights what will be discussed Monday night relative to the General Fund, Criminal Justice Fund, Beautification Fund, and YFS Fund. The Water, Sewer, and Storm Water Funds are addressed less comprehensively in the Utilities section of the Executive Summary, focusing on the proposed 2015-2016 utility rates.

The service enhancements requested by the departments, which are contained in Section H of the budget document, are organized by fund, noting the net cost (i.e. total cost less expenditure savings) of each enhancement, in the table on the next page.

^{*} The firefighter benefit savings noted in the Fire Marshal Re-instatement service enhancement is incorrect. Instead of \$34,774 in 2015 and \$35,643 in 2016, it should be \$8,410 in 2015 and \$8,620 in 2016, thereby making the total expenditure savings \$113,785 in 2015 and \$116,629 in 2016 and the total net cost \$62,018 in 2015 and \$68,160 in 2016.

Following are two new operating budget requests that are not reflected in the 2015-2016 Preliminary Budget, because they came to the City Manager's attention after the document had gone to print:

- Arts Council request to revitalize the outdoor gallery in 2015 (General Fund: \$1,000 in 2015 and \$1,000 in 2016)
- Preliminary staff recommendation following boil water advisory events (Water Fund: \$250,000 in 2015 and \$262,500 in 2016)

These items will be discussed Monday night as well. Currently, Maintenance Department staff, in consultation with the state Department of Health and Confluence Engineering (the City's water consultant), is preparing a short and long term action plan to minimize the risk of another boil water advisory. The action plan will include a number of one-time costs that will be incurred in 2014 and funded by savings on water utility projects and, if necessary, the Water Fund's operating reserve. Other action plan items, which staff intends to present to the Council on November 17, 2014, are expected to have ongoing operational and capital impacts. At this point in time, staff is recommending that a \$250,000 ongoing placeholder be added to the 2015 Water Fund Budget, which was unanimously endorsed by the Utility Board. This estimate will be refined, if needed, for the November 17, 2014 meeting. If approved by the Council, the City's water rates would go up 9.6% in 2015 and 2016 (instead of 7.9% each year as proposed in the 2015-2016 Preliminary Budget). Overall, the total bi-monthly utility bill for a typical single-family residential customer would go up 7.0% in 2015 and 5.5% in 2016 (instead of 6.5% in 2015 and 5.0% in 2016 as proposed in the 2015-2016 Preliminary Budget).

The significant budget policy issues/changes related to the 2015-2016 Operating Budget are organized by fund in the table below (under Budget Document Page #'s, B refers to Section B and I refers to Section I).

Regarding the YFS funding shortfall, there is a new development that is not reflected in the 2015-2016 Preliminary Budget. Due to a recent elementary school counselor resignation, YFS Director Cindy Goodwin has reverted back to the three counselor staffing model for the elementary schools. As a result, the projected deficit in the YFS Fund has increased from \$196,000 to \$260,000 for the 2015-2016 biennium. This will be addressed Monday night too.

Staff will solicit questions and feedback from the Council as each fund is reviewed. Specifically, a preliminary thumbs up or down vote will be sought for the following:

- Significant budget changes (e.g. street sweeping costs from the General Fund to the Storm Water Fund)
- Service enhancements recommended by the City Manager
- Significant budget policy issues/changes

Finally, if the Council wants to re-visit a budget item or issue discussed Monday night, staff will maintain a "follow-up" list for the November 17, 2014 meeting at which the Council will need to finalize all changes to the 2015-2016 Preliminary Budget.
