4. The recorded public easement documents.
5. The reasons and needs for modification/extinguishment of the existing public easement.
6. The benefits to the City for modifying/extinguishing the existing public easements.
7. If the request is for modifications to an existing public easement, provide exhibits and legal descriptions (stamped by the land surveyor) of the proposed modified public easements formatted for recording with King County.
8. Any other relevant documents as requested by City staff.
