On 12/11/2024, the above listed vehicles' speedometers were tested for accuracy. For this test, the listed Radar Operator(s) used KUSTOM Talon radar unit # TA03822 to measure the speed of the vehicles. The measurements were taken by the Radar Operator at a point in time at which the Vehicle Driver notified the Radar Operator that the speed shown on the vehicle's speedometer was 30, 50, or 70 miles per hour. The radar unit is a "stationary radar unit" and was stationary while being used for the test. Immediately prior to and after the test, the Radar Operator performed 1 internal check (radar self-test) and an external check of the radar unit with 55-MPH tuning fork # 42874. The Radar Operator is trained and certified by the WSCJTC to operate the radar unit. The external and internal checks confirmed that the radar unit was working properly at the time of the test. There were no signs of radio frequency interference either during the checks or the test. At the time the speed measurements were taken for each vehicle, the Radar Operator had a clear and unobstructed view of the vehicle. The radar unit displayed the above bracketed speeds at the point in time at which the Vehicle Driver notified the Radar Operator that the vehicle's speedometer displayed the speed indicated in the above table at the top of the column corresponding to the bracketed speeds.
